2. Main Electrical Source:

The main electric source for the building is located in the first office to the right of the front door. The main electrical source is found at the top of the circuit breakers. There are two (right and left) main sources to be shut off.

3. Natural Gas Leak:

- A. Announce an Emergency Evacuation
- B. Call "911" to report fire/explosion hazard.
- C. Notify the President.

4. Water Main Break:

- A. Notify the President.
- B. President will notify the following:
 - 1. Water Utilities 715-381-8220

5. To shut off the main water source:

The shut-off for the main water source for the building is located in the kitchen utility room. The main water source may be shut off by turning the valve to the right.
